What is SCA?

SCA is a 12-Step fellowship, inclusive of all sexual orientations, open to anyone with a desire to recover from sexual compulsion. We are not group therapy, but a spiritual program that provides a safe environment for working on problems of sexual addiction and sexual sobriety. There are no requirements for admission to our meetings: anyone having difficulties with sexual compulsion is welcome.

Meetings are where we share our experience, strength and hope with each other to better understand our common problem and work together toward the solution. Different meetings have different formats and features. An *open* meeting welcomes anyone, sexual compulsive or not. A *closed* meeting is only for sexual compulsives or for people who are trying to find out if they are sexually compulsive. *Speakers* share their stories of hope and recovery. *Chips* are tokens given to those who have maintained sobriety for a specific period of time. *Court papers* may be signed by the secretary of a meeting.
